New Jersey State Law Lead Paint Testing Required in Rental Units

Municipal records indicate your property located at: <<Property Address>> is impacted by the State of New Jersey's Lead Safe law, N.J.A.C. 5:28A and action is required.

Under the provisions of N.J.A.C. 5:28A, New Jersey is mandating periodic inspections for single-family, two-family, and multiple dwellings, with certain exemptions. The law requires landlords to remediate any identified lead-based paint hazards and obtain lead-safe certifications.

Rental properties located in the City of Wildwood must have inspections scheduled by **February 28, 2026**, with the inspection completed before the end of 2025.

UNDER STATE LAW, PROPERTY OWNERS WHO FAIL TO COMPLY WITH THESE NEW INSPECTION AND CERTIFICATION REQUIREMENTS COULD RECEIVE FINES OF UP TO \$1,000.00 PER WEEK

Why Did I Get This Notice?

If you're a single-family home, your property could have been flagged as a potential rental because your property address differs from your tax billing address. If you are a two-family home, your property could have been flagged under the assumption that at least one of the units is rented. There are various circumstances that may lead to a property being flagged as a potential rental, and we have partnered with LEW Environmental to ensure the records are accurate. If you believe your property has been incorrectly identified as having a rental unit, please contact LEW Environmental or scan the QR code below to quickly and easily update the city's rental records.

Exemptions

Properties constructed after 1978, seasonal rentals, or those with prior lead-free certification are exempt. Owners of multi-unit buildings registered with the DCA for over 10 years should consult LEW Environmental regarding potential exemptions.

If your property is not rented/is a short-term rental do not get upset about this notice, please just email the property address to info@njleadlaw.com or call LEW Environmental and let them know this is not a rental/short-term rental.

How it Works

To facilitate compliance, the City of Wildwood has established a partnership with LEW Environmental. As the approved partner, LEW Environmental offers:

- \$295 inspections (plus any applicable state and local fees)
- Lead-Free Certificate - A lead-based paint XRF inspection costs an additional \$150 per unit, but if the unit is certified lead-free, it's exempt from all future lead inspections.
- Automatic state filings
- Guaranteed deadline compliance if services are scheduled by **February 28, 2026**.
